**Specification of flats**

These are multistoried flats provided with facilities viz; plumbing, internal and external water supply, sewerage, electrification etc.

Applicant will have to submit the application complete in all respect in the enclosed performa alongwith 10% cost of flats in shape of demand draft in favour of M.D HEWO, Panchkula and shall reach by 15.03.2021 in the office of M.D. HEWO, C-3, HSVP Complex, Sector-6, Panchkula, either through registered post or in person. No claim on account of delay shall be entertained.

**Other Terms & Conditions will be as under:-**

1. The application be submitted in the enclosed application format.
2. A draft of 10% of cost of flat in favour of Managing Director HEWO, Panchkula payable at Panchkula/Chandigarh will be enclosed with the application. The application received without Earnest Money shall be straightway rejected.

3. One applicant can apply only one flat in one Urban Estate.
4. Next 90% of cost of flat shall be deposited within 120 days from the date of issue of Letter of Intent (LOI). The LOI will be sent on the Email ID provided by the applicant. In case of default the allocation will be cancelled and amount will be refunded after deducting 20% amount of the earnest money as per HEWO policy.
5. Deposit of 10% amount will not create any right whatsoever for the allocation of membership. In case numbers of applications are more than number of available flat, the same will be decided through draw of lots.
6. The particular floor and flat will be allocated through draw of lots.
7. Allotment/Possession of flat will be handed over on receipt of full cost of the flat including Land cost/Enhancement cost. However, in future any enhancement received from the concerned Estate Officer will be paid by the applicant.
8. In case applicant is un-successful in the draw of lot the refund will be made without any interest in the same account provided by the applicant.
9. Number of flats for General Public is restricted upto 49% of the total flats at site.
10. Government serving employees to enclose proof of service viz office Identity card, certificate issued by the office from the competent authority and retired employees to enclose copy of pension pay order letter (PPO).

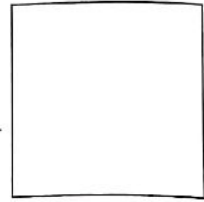
