Specification of flats:-

These are multistoried flats provided with facilities viz; plumbing, internal and external water supply, sewerage, electrification etc. The constructed flats ready to enter are being sold on as is where is basis.


Applicant will have to submit the application complete in all respect in the enclosed performa alongwith 10% cost of flats in shape of demand draft in favour of M.D HEWO, Panchkula and shall reach on or before 20.02.2026 in the office of M.D. HEWO, C-3, HSVP Complex, Sector-6, Panchkula, either through registered post or in person. No claim on account of delay shall be entertained.

Other Terms & Conditions will be as under:-

1. The application will be submitted, indicating full particulars i.e. name, designation, father's name and permanent address (on the performa enclosed alongwith affidavit).
2. A demand draft of 10% of cost of flat in favour of Managing Director HEWO, Panchkula payable at Panchkula/Chandigarh will be enclosed with the application. The application received without Earnest Money shall be straightway rejected.
3. The particular floor and flat will be allocated through draw of lots.
4. Balance 90% of cost of flat shall be deposited within 60 days from the date of issue of Letter of Intent (LOI). The LOI will be sent on the Email ID provided by the applicant. In case of default the allocation will be cancelled and amount will be refunded after deducting 20% amount of the earnest money as per HEWO policy.
5. Deposit of 10% amount will not create any right whatsoever for the allocation of membership. In case numbers of applications are more than available flats, the same will be decided through draw of lots.
6. Allotment/Possession of flat will be handed over on receipt of full cost of the flat including Land cost/Enhancement cost. The land cost and enhancement cost has been updated upto 31.05.2026. In case of delay in depositing cost of the flat the land cost and Enhancement cost shall be updated with 15% interest payable to HSVP. However, in future any enhancement received from the concerned Estate Officer will be paid by the applicant. Hence the cost of flat can increase at any stage of time.
