I am directed to address on the subject cited above and invite your kind attention to this office letter of even no. dated 03.06.2022, wherein, it was informed that, vide Government order No. 05/52/2016-1AR dated 29.01.2021 a Monitoring Committee, to monitor the recovery of penalty imposed by the State Information Commission, Haryana under Section 20(1) of the RTI Act, 2005, was constituted. A meeting of the said Committee was held on 30.09.2021 under the Chairmanship of Chief Secretary, Haryana. In the meeting it was decided to send updated list of all such cases in which penalty has not been recovered by the Commission from the concerned Secretary/HOD for effective recovery. Now the Commission has again sent updated list of all such cases in which penalty has not been recovered by them (Annexure "A").



2. The Government has taken serious view of this lapse on part of the controlling authorities and decided that the amount of penalty be recovered from the concerned State Public Information Officer as soon as possible, If these orders are not taken seriously by the public authorities, then strict action will be taken against him/her as per provision made in Haryana Civil Services (Punishment and Appeal) Rules, 2016. All the controlling authority are directed to recover the penalty amount from the public authorities as Annexure "A" and send a compliance report to the Registrar, State Information Commission, Haryana.

3. It has also been decided that controlling authorities may not issue Last Pay Certificate/No Dues Certificate to such SPIOs till he/she deposits the amount of outstanding penalty vide letter No. 05/52/2016-1AR dated 02.08.2019.

4. These instructions/orders may be brought to the notice of all concerned for immediate and strict compliance.
