Kindly refer to the attached proceeding dated 27.09.2024. You are requested to take possession immediately or upon vacation of the quarter allotted to you and submit the required affidavit alongwith your consent within 15 days from the issuance of this offer letter. If the same is not submitted, your allotment is liable to be cancelled. Allotment is subject to the following terms and conditions.

- 1. You will have to pay the double of license fee as per rules in force from time to time
- The Electricity and water charges will have to be paid by you separately.
- This allotment is purely temporary and the house is to be vacated whenever desired by HSVP. On transfer you will have to vacate the above said house within 2 months from the date of relinquishing/relieving the charge and in case of retirement, the accommodation shall be vacated within 3 months positively, otherwise 300 times license fee of the normal fee as per Govt. Rules would be charged by HSVP.

- 4. In case of non-acceptance of allotment or failure to occupy the house within 15 days after vacation by the present allottee, you will be debarred for allotment of house for the next one year and your name will not be entertained for next one year under any circumstances.
- 5. The allotment is not valid, if you are transferred outside Panchkula/Chandigarh or retired from the Govt. HSVP, Service before the date of taking over the possession of the HSVP staff quarter.
- 6. In case of allotment of earmarked house, the allottee shall have to vacate the earmarked house within two months after he/she ceases to hold the post for which the residence stands earmarked.
- 7. On vacation, damage/shortage, if any, found will be made good from you.
- 8. No Dues Certificate of presently occupied staff quarter from UHBVN & HSVP will be required to be submitted by you at the time of handing over the possession of this house.
- 9. In case of allotment of HSVP accommodation to the employees/officers of other department i.e. Urban Estate, Town & Country Planning and CCP (NCR), they have to submit an undertaking within on month positively.

From their DDO ensuring therein that the license fee and HRA drawn by the official/officer will be deposited with HSVP every month, falling which this officer of allotment of HSVP accommodation will stand withdrawn automatically and they will have to pay penal rent equivalent to 50 times the normal rent from date of possession.
